# **TERMS & CONDITIONS**

#### **Registration and Enrolment**



- No Registration Fees: DAPA does not charge a registration fee.
- Enrolment Requirement: All students must complete their enrolment and set up direct debit payments before attending any dance classes.
- **Payment Compliance**: Only students with active payment arrangements can participate in classes. Students may be asked to leave if fees are unpaid.
- **Term Structure**: Enrolment operates on a 10-week term, with lessons billed monthly during the term.

# Term Fees

- **Monthly Billing**: Fees are charged via direct debit on the first day of each term and will be debited on that day each month during the term. *For Term 1, debits start in Week 2 to accommodate new enrolments.* Upfront payment is not available.
- Sufficient Funds & Account Details: Ensure that sufficient clear funds are available in your nominated account, and confirm your bank details are correct.
- **Debiting:** We will only debit your account for amounts due as per lesson total for each month.
- **Payment Responsibility**: By enrolling, you agree to pay all fees for your child. Non-payment will result in your child being excluded from lessons.
- Fee Enquiries: Class teachers cannot address fee-related questions. Please email Ali (Principal) at dancealleyperformingarts@gmail.com for assistance.

# **Medical Consent**

• **Risk Awareness**: Dance classes involve a risk of personal injury. While DAPA takes reasonable care, it is not responsible for injuries or losses during classes or on studio premises.

# Photography, Video/DVD, and Promotions

• **Recording and Usage**: By enrolling, you agree that DAPA may record events (e.g., concerts, rehearsals, and classes) for promotional purposes. Videos/DVDs may be shared with parents, displayed on the website, or posted on social media.

# **Emergency Procedures**

• **Medical Emergencies**: In emergencies, if parents/guardians cannot be contacted, teachers may call an ambulance if necessary. Parents/guardians are responsible for any associated costs.

# Concerts

• End of Year Concert: Participation in the End of Year Concert at the end of Term 4 is mandatory unless otherwise arranged during enrolment.

#### **End of Year Concert Costumes**

- **Costume Requirements**: Performance classes require costumes for the End of Year Concert, with prices varying by age group. Costume invoices will be sent in Term 3 and must be paid in full for participation.
- **No Refunds**: Costume payments are non-refundable as costumes are ordered and paid for in advance.

#### **Missed Lessons**

• Attendance Policy: Fees are still payable for missed classes due to illness or holidays. Make-up classes may be offered if available.

# **Public Holidays**

• **Class Adjustments**: No classes are held on public holidays, and term fees are adjusted accordingly.

#### **Cancellation of Enrolment**

- Enrolment Commitment: Enrolment is for a full 10-week term. To cancel, email the Principal at least 3 days before the next billing cycle.
- End-of-Term Cancellation: Enrolment cancellations take effect at the end of the term.

# **Cancellation of Classes**

- **Class Cancellations**: DAPA may cancel classes due to unforeseen circumstances. Advance notice will be provided where possible via email or SMS.
- Make-Up Classes and Credits: If a class is cancelled, a make-up session will be offered, or a credit will be applied to the student's account for the next term.
- **Class Changes**: Classes may change based on demand. If a class is cancelled, alternative options will be provided, or a refund will be issued if no suitable class is available.

#### Refunds

• Fee Refunds: Term fees are non-refundable.
